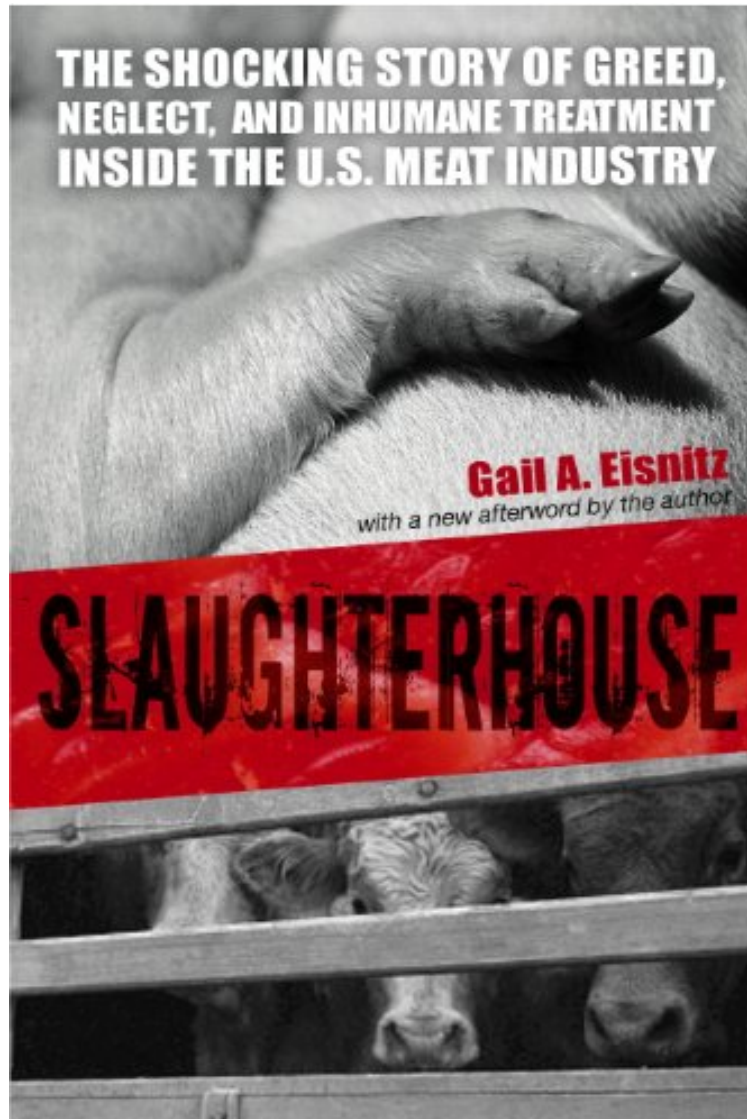

interviews in an attempt to expose USDA's failure to uphold federal standards. Her collection was brutal and disturbing. After each interview, I felt disgusted by my naive trust in the meat industry for the first 21 years of my life. She develops an argument against the meat industry's current business standards and operations by conveying its negative social and environmental externalities not through statistics and scientific research but through human experience. Towards the end of her story, she really cracks into the heart of the problem. She explains that too many people have turned a blind eye. The information is right in front of them, but they refuse to accept that their way of life is socially and environmentally destructive. She concludes by saying that, despite her many set backs, she accepts that all she can do is tell her story and the stories she has collected. *Slaughterhouse* is the first book of its kind to explore the impact that unprecedented changes in the meatpacking industry over the last twenty-five years — particularly industry consolidation, increased line speeds, and deregulation — have had on workers, animals, and consumers. It is also the first time ever that workers have spoken publicly about what's really taking place behind the closed doors of America's slaughterhouses. In this new paperback edition, author Gail A. Eisnitz brings the story up to date since the book's original publication. She describes the ongoing efforts by the Humane Farming Association to improve conditions in the meatpacking industry, media exposés that have prompted reforms resulting in multimillion dollar appropriations by Congress to try to enforce federal inspection laws, and a favorable decision by the Supreme Court to block construction of what was slated to be one of the largest hog factory farms in the country. About the Author Gail A. Eisnitz (San Rafael, CA), winner of the Albert Schweitzer Medal for outstanding achievement in animal welfare, is the chief investigator for the Humane Farming Association. Her work has resulted in exposés by ABC's Good Morning America, PrimeTime Live, and Dateline NBC, and her interviews have been heard on more than 1,000 radio stations. Her work has been featured in such newspapers as The New York Times, Miami Herald, Detroit Free Press, Texas Monthly, Denver Business Journal, Los Angeles Times, and US News World Report.
